

Chapter Planning



Why are we doing this?

- To give the Board visibility to the organization's needs for their long-range and mid-term planning
- To be able to articulate your vision to potential supporters
- To increase your impact and further our mission
- To understand what you need to say "no" to so you can say "yes" to what is most important
- Your 3-year picture will clarify your 1-year plan, which will inform budgeting and help build momentum

A Note on Key Measures

- Don't overthink them!
- They should be directional
- They can paint an inspiring picture for your future
- You don't need to account for every potential obstacle



Agree on Key Measures

- 1. Imagine that it is March 31, 2027
- 2. Determine your chapter's revenue target
 - Include all sources, e.g. individual contributions, grants, events, fee for service
 - Ask each participant to jot down and then share what they think your annual revenue will be in three years
 - Debate and decide on one number (not a range)
- 3. Repeat the process for the number of members and the number of volunteers



Paint Your 3-Year Picture

- Give everyone 5 minutes to jot down what they think your chapter will look like in three years
- Things to consider:
 - People involved their roles, the number, etc.
 - Added resources needed
 - Land protection work completed
 - Land management accomplishments
 - Education programs
 - Outreach opportunities
 - Systems improvements
- Share back ideas, then debate and decide on 10-20 bullets that describe your shared vision



Now, close your eyes and imagine...

The facilitator will read your 3-year picture aloud and ask:

- Can you see it?
- Do you believe in it?
- Do you want this to be true for your chapter 3 years from now?

Continue to debate and discuss until you have agreement.

1-Year Plan

Time required: two hours





Agree on Key Measures

- 1. Imagine it is March 31, 2025
- 2. Determine your revenue target
 - Include all sources, e.g. individual contributions, grants, events, fee for service
 - Ask each participant to jot down and then share what they think your annual revenue will be in three years
 - Debate and decide on one number (not a range)

Create Your 1-Year Plan

- Discuss, debate and decide on 3-7 most important priorities that <u>must</u> be completed to be on track to achieve your 3-year picture
- Craft goal statements that are specific, measurable and attainable
- Revisit your budget do you have the resources to achieve your goals? Determine how to balance your aspirations for the coming year with your likely resources.
